## Purposes Of The Processing – Type Of Personal Data Treated

- Your data will be processed for the following purposes:
- Customer management
- Administration of offers, contracts, orders, shipments and invoices
- Fulfillment of tax and accounting obligations
- Quality & Safety management
- Planning of activities
- Detection of the degree of customer satisfaction
- Management of litigation

#### Legal Basis Of The Treatment

For these purposes, the processing of your personal data is made lawful, without the need for a specific provision of your consent, by the agreements existing between you and the Data Controller, as well as by the consequent legal obligations of the Data Controller itself. The communication of your personal data is a necessary requirement for the correct execution of the relationship between you and the Data Controller.
